Preliminary Examination Overview

The IBPS Clerk Preliminary Examination is an objective-type online assessment designed to evaluate candidates on aptitude, intellect, and linguistic proficiency. This serves as the initial screening phase of the recruitment process.

Key Instruction: Candidates must clear the cut-off for each section to proceed. Each section is strictly timed at 20 minutes.

Rules of Assessment



Penalty for Wrong Answers

Precision is as vital as speed. Both Preliminary and Main examinations carry a negative marking scheme:

0.25 Mark Deduction

One-fourth of the marks assigned to a question will be deducted for every incorrect response.

Note: No penalty is applicable for questions left blank or unanswered.

Final Score Calculation

The final merit is determined based on the following selection criteria:

- **Phase-1 Exclusion:** Marks obtained in the Preliminary Exam are used for shortlisting only and are not considered for the final selection.
- **Mains Qualification:** Candidates must strictly qualify in Phase-2 to be eligible for the merit list.
- **Aggregate Scaling:** The aggregate score is normalized to a total out of 100 for the final merit list creation.
- **Merit Ranking:** Candidates with top merit ranks within their respective categories are selected for provisional allotment.
